Dr. Viktor E. Krebs did his Adult Reconstruction Fellowship training at New England Baptist Hospital after a residency at the Cleveland Clinic. He is currently the Vice Chairman of the Cleveland Clinic Department of orthopedic surgery and has been since 2015. Prior to that appointment, he was the head of Adult Reconstruction since 2005. He has helped expand and refine the Cleveland Clinic Adult Reconstruction Fellowship from its origins with Dr. Lester S. Borden, MD in the 1970s, and continues to function as the Fellowship Director. He continues a very busy and active revision practice at Cleveland Clinic. He is a long-standing member of AAHKS and has been on the editorial board for the *Journal of Arthroplasty* since 2012 as an Associate Editor.
