Proposed Bylaws Changes

SUBJECT: Change in Associate Member Eligibility

Add the following red text:

SECTION G. ASSOCIATE MEMBERS

1. Eligibility for Associate Membership:

- a. An orthopaedic surgeon who does not qualify for Fellow status and has an interest in the advancement of orthopaedic knowledge of the hip and knee joint in health and/or arthritic disorders; **or a physician (MD, DO) who has a clinical role in treating patients undergoing hip and/or knee arthroplasty.**

2. An applicant for Associate Membership:

- a. Shall regularly perform total hip and/or knee arthroplasties or osteotomies about the hip and/or knee each calendar year **or, if a physician but not an orthopaedic surgeon, provides clinical care for patients undergoing total hip and/or knee arthroplasty.**

Proposed Bylaws Changes

RATIONALE:

- Subject: Change in Associate Member Eligibility
- This would amend the Associate Member category to include physicians who have a clinical role in treating patients undergoing hip and/or knee arthroplasty but are not orthopaedic surgeons.
- A growing number of other specialists, such as anesthesiologists and internists focus their practices on the treatment of hip and knee arthroplasty patients in the perioperative period, during preoperative optimization and post operative rehabilitation.
- These providers attend the AAHKS Annual Meeting, read the AAHKS journals and seek access to AAHKS member benefits, often with the encouragement of the AAHKS-member surgeons with whom they work.
